## **Systems**

- Gathering Systems gather and transport crude petroleum from the lease to a number of different destinations, including rail terminals and connecting pipelines.
  - o Tioga Gathering
    - Gathers crude petroleum at the lease and transports to Tioga Terminal for further delivery to Enbridge Pipeline Beaver Lodge, ITT Dakota Access or Hiland's Market Center system bound for various rail or other connecting pipelines.
  - Richland County Gathering
    - Gathers crude petroleum in Richland County, MT and transports to Bridger Poplar system, Plains Pipeline Lone Tree station, or into Hiland's Double H Pipeline.
  - Market Center Gathering
    - Gathers crude petroleum in McKenzie, Williams and Mountrail counties, ND and transports to the following destinations:
      - Enbridge Beaver Lodge
      - Plains Rail Manitou
      - New Town Terminal for further delivery to Dakota Plains Rail
      - Crestwood Crude Logistics, Epping, ND

  - o For further delivery to Hiland Crude Double H Pipeline
