Re: Advice Letter No. 20 of Calnev Pipe Line LLC (PLC-1)

Dear ED Tariff Unit:

Calnev Pipe Line LLC ("Calnev") hereby submits its Advice Letter No. 20 in compliance with General Order 96-B, along with the following revisions to its tariff:

Tariff Cal PUC 21 (canceling Cal PUC 20) revises Item 100 of Calnev's tariff terms and conditions in order to reflect that shippers will be subject its revised Tendering and Scheduling Policy as of February 1, 2018, the effective date of this tariff filing.

Calnev makes this filing to revise Item 100 (Tender of Petroleum) of Calnev's Rules and Regulations, Cal PUC 21, in order to reflect that shippers will be subject to its revised Tendering and Scheduling Policy, as of February 1, 2018, the effective date of this filing.

Calnev has received overwhelming shipper support for its new web based nomination system, but for those shippers who would prefer to continue providing their nominations manually, Calnev has provided a solution to accommodate their business processes. Calnev's has revised its Tendering and Scheduling Policy establishing for customers who elect not to utilize its electronic nomination interface and instead provide nominations manually will be accessed a manual data handling fee of \$10 per batch and/or renewable fuel truck nominated, plus an additional \$10 fee for each subsequent change after nominations are accepted, subject to a minimum fee of \$1500 per month.

Additionally, Note ① on page 10 of Cal PUC 21 provides instructions on how to locate Calnev policies referenced in this tariff, including the revised Tendering and Scheduling Policy, on its website (www.kindermorgan.com).

The proposed rule revision will have no impact upon Calnev's existing rates. Given that the requested tariff change is consistent with existing Commission authorization, Calnev is submitting AL 20 as a Tier 2 filing, requesting that AL 20 become effective February 1, 2018, subject to staff approval. Additionally, on page 1 are ministerial changes to reflect current information.
