**12 mth DART** (Days Away, Restricted, Transfer Rate) - Calculates all Contractor OSHA DART cases and exposure hours for the 12 months ending.

**12 mth LTIR (Lost Time Incident Rate) / LTC (Lost Time Cases)** - Calculates all Contractor OSHA lost time cases and exposure hours for the 12 months ending.

**3-Yr TRIR and 3-Yr DART** - Calculates actual KM Contractor performance for previous three completed calendar years (average).
